The Government of Malawi through the Northern Region Water Board has received financing from the African Development Bank hereinafter called the Bank toward the cost of the Rumphi Water and Sanitation Services Improvement Project and intends to apply part of the proceeds toward payments under the contracts for **Construction of Engineered Landfill in Rumphi District**.
